#### **PUBLIC PARTICIPATION**

- Andrew Jefferies reported fly tipping at the junction of Old Bath Road and the road from Fortnight Farm, including of glass and tiles.
  - He had reported an infestation of Japanese Knotweed to B&NES but had had no response. The Clerk to contact B&NES and Ward Cllr D. Veale.
- Carol Smith spoke to her application for Smithy House. She said due consideration had been given to the surroundings. The stone had been chosen to blend in, only two dormers overlooked neighbours and the extension would not be seen from the roadside, where the unstable wall would be reinstated. The aim had been to prepare for the future while respecting the past. The house at the bottom of the hill had been referenced for the cedar cladding. A lot of the work did not require planning permission and was being undertaken.
- John Holdaway also spoke to the Smithy House application. He thought the volume
  of the extension too great and was not keen on the finish to the north side or the
  dormer windows. He also considered the parking area too big,

# 18.026 Highways and transport

# (a) Flooding at Anchor Lane.

- The large hole had been filled in by Bristol Water and the warning signs removed.
   The road continued to be heavily affected by surface water
- The Clerk to contact Simon Morrissey, B&NES senior drainage engineer, to ask about discussions with the owner of the wall from which water was issuing and confirm when the engineering work would be done (scheduled for the first three weeks of September)
- The B&NES Highways Inspector to be asked to alleviate matters in the meantime if possible

# (b) Highway works

- B & NES to be consulted about designating passing places on Swann Lane, which is used as a rat run
- B&NES to be asked to clear two blocked gullies west of Combe Hay crossroads
- A request for grit bin refills had been made but only partially met. The remainder to be chased
- It was AGREED to ask B&NES for a weight limit in Combe Hay Village as well as on the full length of Combe Hay Lane

## 18.027 Rights of Way

There was no information to report.

## **18.028 Cemetery**

(a) Councillors reviewed the map of water pipes in the proposed new land and noted the need for planning permission for change of use to a cemetery.

Cllr Harrison said the offer of the land should be accepted. Other considerations, apart from maintenance and insurance, which would have to be allowed for but were manageable, could follow.

- (b) **RESOLVED** (proposed Cllr Harrison, 2<sup>nd</sup> Cllr Young) to resume the process of acquiring the new land north of the cemetery and to spend up to £500 on legal and professional fees.
- (c) It was AGREED that ivy on the cemetery wall should only be removed by cutting or spraying, not pulling.
- (d) The contractor to be asked to cut only one narrow strip up the cemetery for the first cut.

#### 18.029 Risk assessment

Following a site visit to Smithy House, during which one member of the public was in attendance, Councillors considered resumed consideration of application 18/000750/FUL.

18/00750/FUL Smithy House	<b>RESOLVED</b> (proposed Cllr Long, 2 <sup>nd</sup> Cllr Austwick, unanimous) to <b>object</b> to the proposal in its current form on the following grounds.
	In CHPC's view blank side wall is overbearing, rising at its highest point about 4.5 metres (existing boundary wall plus 2.6 metres building height) above Flowers Lane. The visual aspect of this side wall is dominant. The extension is also overbearing when viewed from the bottom of the hill and should be tempered by a softer approach. It could be lowered, have a gently sloping roof and use materials more in keeping with its surroundings.
